Additionally, AP standards are used for courses in Calculus, English Comp, English Lit, Government, US & World History, Macro Economics, Spanish, Chemistry, Environmental Science, Art, Psychology, and Computer Science. Dual Enrollment courses are also offered in a multitude of subjects through Indian River State College.

A variety of assessments are used to measure a student's progress throughout the school year. These assessments include, but are not limited to PERT, SAT, ACT, EOC's, FSA, AP assessments, etc. Each assessment provides meaningful information about a student's academic success and progress and is used to track their progress towards graduation.

Student achievement is measured with multiple indicators ranging from number of credits earned, to GPA, to FAST/PM, FSA/EOC scores. For grade promotion, students are expected to reach mandated thresholds for numbers of credits. For graduation, students are required to carry a 2.0 or better GPA while earning proficiency scores of 3 or better in FSA/EOC courses - these parameters apply to the 24 and 18 credit graduation options. Additionally, PERT, SAT, ACT, and/or PSAT scores can be useful in qualifying students for Dual Enrollment courses where the GPA requirements rise to 3.0 for most classes.
